Investment Objective

The objective of the Fund is to preserve capital, maintain liquidity and generate current income by investing in high qualityshort-term fixed income or adjustable rate securities denominated in the base currency of the Fund.

The Fund is a Short Term Low-Volatility Net Asset Value (LVNAV) Money Market Fund as defined by the EU Money Market Funds Regulations. LVNAV funds are valued using a mixture of the amortised cost and market pricing to facilitate a stable NAV. However in certain circumstances LVNAV funds may be priced with a variable NAV. The Fund invests in high quality short-term government and corporate bonds as well as cash deposits and debt instruments issued by financial institutions.

All securities in which the Fund invests will be denominated in US Dollars and at the time of purchase have a minimum credit rating of A2/P1 by Moody's credit rating agency or an equivalent rating from another agency and will have a maximum maturity of 397 days.








CREDIT BREAKDOWN (%)

Yield to Maturity (%): is the total return anticipated on a bond if the bond is held until it matures.
