This is a communication to notify you of changes to the names of the Funds (the "**Fund Name Changes**").

Background

In May 2024, the European Securities and Markets Authority ("**ESMA**") published guidelines in respect of funds' names using ESG or sustainability-related terms (the "**Guidelines**"). These Guidelines apply to Undertakings for Collective Investment in Transferable Securities ("**UCITS**") that are regulated in the EU (i.e., the Funds), and therefore the Fund Name Changes are required to ensure the Funds compliance with the Guidelines.

While ESMA did not provide a complete list of words that trigger a requirement to comply with the Guidelines, they did provide a non-exhaustive list of relevant words/terms which are provided in Appendix A of this notice for ease of reference.

Summary Overview of Fund Name Changes

As a result of the Guidelines and as part of our ongoing commitment to sustainable investing, we have made the Fund Name Changes to the Funds. These changes reflect the evolving sustainable investing landscape and enhance transparency to investors. We have made these updates the week commencing 17 February 2025. The Fund Name Changes do not impact the investment objective or policy of the Funds.

For the avoidance of doubt, the Fund Name Changes as described in this notice will have no impact on the Funds' classification under the Sustainable Finance Disclosure Regulation (Regulation EU/2019/2088) as amended ("**SFDR**"). To confirm, SFDR classifications will remain the same.

Timing

The changes detailed have taken effect as of the date revised Supplements reflecting such changes is noted by the Central Bank, which is from 17 February 2025 (the "**Effective Date**").

APPENDIX A

The table below is as summary the ESMA Guidelines by ESG-term and their respective requirements from 21 May 2025.

ESG Term	Example	Minimum Exclusions	Additional Requirements
Sustainable, Sustainability	"SDG"	Paris Aligned Benchmark ('PAB')	Commit to invest a minimum of 50% in sustainable investments.
ESG-related terms	"ESG", "SRI"	Paris Aligned Benchmark ('PAB')	80% investment threshold
Environmental terms	"Low Carbon", "Climate", "Green"	Paris Aligned Benchmark ('PAB')	80% investment threshold
Social terms	"Social", "Equality"	Climate Transition Benchmark ('CTB')	80% investment threshold
Governance terms	"Governance", "Controversies"	Climate Transition Benchmark ('CTB')	80% investment threshold
Transition terms	"Improve", "Progress", "Evolution", "Transformation"	Climate Transition Benchmark ('CTB')	80% investment threshold. Demonstrate investments are on path to transition.
Impact terms	"Impacting", "Impactful"	Paris Aligned Benchmark ('PAB')	80% investment threshold. Demonstrate investments are made to generate impact.
