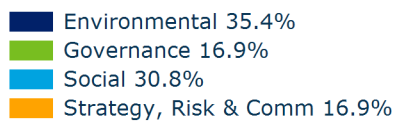

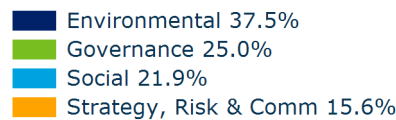

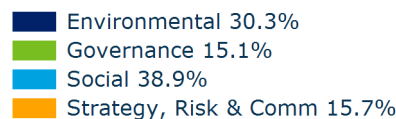

Environmental topics featured in 35.4% of our engagements



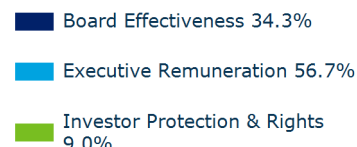
Social
